Rusty called the meeting to order at 6:30 p.m. The minutes of the October 4th meeting were approved as written.

OWNERS' ISSUES

Dennis Seymour discussed the need for repairs to the wave screen which should be done before winter. The committee will meet at 6 p.m. on Monday, October 30th. Ron will speak with Dennis about other suggestions.

Dennis noted that the lighting on the new stairs to the marina is inadequate. Existing lights need to be readjusted and two more should be added. He recommended LED lights. Ashley will contact JMJ to see if they will handle this

Dave Cosca asked about the letters received concerning trees in back yards. The purpose was to identify trees that may cause damage if they were to come down in a storm and to remind the homeowners that any damage would be their responsibility.

Dave also reported that he had a slight backup of sewage in his basement shower. He said it was a one-time event but will keep an eye on it.

COMMITTEE REPORTS

ARCHITECTUAL REVIEW

The committee recommended the request for a 7.5 to 8 foot tall "catio" in the back yard of unit 102 be denied. After some discussion the board moved to approve a shorter (5'8") version since it is a non-permanent, free-standing structure. The motion passed.

FITNESS CLUB

The accounting issues for the club were discussed. There has been some confusion concerning whether or not this should be a separate account. A full accounting of dues, expenses and rent paid from the club to the association is still in progress.

GROUNDS

- 1. BrightView has collected up all of the leaves that have fallen to date. We expect this will happen at least two more times.
- 2. With the change of the weather our reseeding efforts are working
- 3. Many of the 17 homeowners with overgrown trees in their backyards have begun dealing them. Brodie has been following up with neighbors that have not responded.
